## Introduction:

Needs have to be known in their entirety to be addressed, are not isolated. They impact on all areas of the person. If they are tackled in an isolated way, the impact will be negative, preventing integral development and social inclusion. If they are addressed in full in a coordinated way the impact will favor both acceptance and personal development and social inclusion.

Coordination between systems is necessary to cover all the needs of the person in their environment, college, labor center, community, hospital, etc, these areas do not depend exclusively on a single system, to be addressed as a whole, it is necessary to establish coordination mechanisms that must be regulated by a normative framework for their effectiveness.

## Conclusions:

We have detected in the process that the protocol will be effective if it is accompanied by the relevant regulations. Thus we have requested the Departments of Education and the Rare Diseases Advisory Council of the Departments of Health, include the following in the full inclusion decree: the educational compensation measures intended for these pupils "Periodic attention by healthcare staff in the educational center".

## Objective:

Full School inclusion of students affected by rare diseases, who need regular health care at the school.

Protocol for the reception and care of children with rare or infrequent diseases in the schools of Extremadura.
